#### **UPUA Supports New Central Support for Mental Health Efforts**

**UNIVERSITY PARK, Pa. – Feb. 16, 2017** – The University Park Undergraduate Association (UPUA), on behalf of the University Park undergraduate student body, supports President Barron's announcement of new central support for mental health efforts.

The new support will come in the following manner:

- 1. Starting on July 1, the Office of the President will provide \$365,000 new funding for Counseling and Psychological Services (CAPS). In addition, President Barron will assume financial responsibility for a position currently paid for by athletics, bringing the total to \$450,000. The source of these funds will be announced at the Board of Trustees meeting later this month. The funding level is guaranteed for the next six years, but is certain to continue thereafter.
- 2. Corporate donations totaling \$7 million, that give President Barron broad discretion in how the funds can be used, will be placed into endowed status to support CAPS functions. At current rates, this fund should provide \$315,000 annually. These funds will become available annually starting on July 1, 2018. An additional \$25,000 will be added to bring the total annual central contribution to \$705,000 in new dollars.
- 3. The distribution of these funds will be based on the distribution of students paying fees, which is currently 59 percent University Park (UP) and 41 percent Commonwealth (CC). Thus, the new funding for UP will be \$215,000 on July 1, 2017 and \$415,000 starting on July 1, 2018. The new funding for CC will be \$150,000 on July 1, 2017 and \$290,000 on July 1, 2018.
